This will be the last year for this event as it gets difficult to come up with a program with various challenges in the different areas, so as the event remains interesting for the participants (75 teams of 2), as the challenges remain secret until the event. The history of the event was presented, award received in 2022 and the accomplishment of promoting northern N.B. for adventure tourism.
