2022 Budget Preparation - Working Session #2

The following Budget Expenditure Services were reviewed for the second meeting with the exception of Personnel, which will be discussed at a future Closed Session of Council – permitted by legislation.

General Government

No changes made to this section from 1st Meeting

Protective

• No changes made to this section from 1st Meeting

Transportation

- Engineer \$15,000 same as previous year
- Road & Streets \$125, 000, with discussion on the Mitchell/Lawlor intersection
- Culverts & Drains \$20,000 same as previous year
- Other areas to be discussed with public works and information pending from DTI on maintenance costs

Environmental Health

• No changes made to this section from 1st Meeting

Environmental Development

- Economic Development Growth previous year \$90,000 was removed and the Economic Development Grant was increased from \$50,000 to \$70,000.
- Discussion on Housing Incentives Grants and the Policy was discussed regarding whether this will continue or not. No firm decision made.
- Student Subsidy Program remains at \$30,000 with further discussion on how to bring the usage by businesses back up
- Other Development Services Tourism HR (seasonal position) did not happen in 2021 and it was removed from the 2022 Budget.
- Christmas Decoration Budget increased back to \$10,000 the community have very positive comments.

Recreation

- Recreation Health & Wellness Programs was increased from \$20,000 to \$25,000 base on submission by Health and Wellness Coordinator's proposed plans
- Fairs /Festival and Community Events Budgets remain the same as previous year
- Parks & Playgrounds remain the same as previous year

Fiscal

- Debt & Interest Payments are as per the payment schedule
- No Capital project have been identified at this time

Personnel costs will be discussed at the next meeting in Closed Session – October 25th, 6:30 P.M. CAO, Ferguson will attend that session.
