• Zoning Provisions of a Rural Plan Amendment, PID 20277547 and 20276655

Lilliane Carmichael moved At the Village of Belledune Council meeting held on August 21, 2023, it was resolved to seek written opinion from the Regional Planning Advisory Committee of the Chaleur Regional Service Commission on the proposed by-law amending the zoning provisions of the rural plan with respect to the following proposal:

Change the rural plan by-law to add two tiny home (41 square meters), one on the lot with the PID 20277547 and one on the lot with the PID 20276655.

It is pursuant to subsection 110(1) of the *Community Planning Act* that we kindly ask you to study this project and to provide us with your written notice within 30 days of this request, seconded by Marilyn Guitard-McDonnell. MOTION CARRIED.

- Zoning Provisions of a Rural Plan Amendment 35 Laviolette Road

The owner already has a mobile business and would like to operate a light mechanic business on his property who are residential. The objective is to permit the use "light mechanic" as an accessory use to the principal one "residential."

- Roherty Road Recommendation

- Councillor Bourque wanted clarify that he is in favour of this motion considering the opportunity of long-term benefits that would come from developing Roherty Point. Councillor Robinson asked about the tender being distributed without the WAWA permits being approved, CAO Lee informed council that the WAWA permits were provided by the Province prior to the tender being issued. Councillor Robinson also indicated this type of project should align with our CAMP which is not yet completed. Deputy Mayor suggested Roherty Point is likely the best beach access we have in the municipality. Councillor Carrier suggested that any person opposed to this development should consider visiting Charlo or Petit-Rocher to see the success in this type of development.
- Jacquet River Tennis Court Upgrading
