Call to Order

• Mayor, Arseneault called the meeting to Order and commenced the meeting with the following statement:

We would like to begin by acknowledging that the land on which we gather is the traditional unceded territory of the Mi'kmaq Peoples. This territory is covered by the "Treaties of Peace and Friendship" which Wəlastəkwiyik (Maliseet), Mi'kmaq and Passamaquoddy Peoples first signed with the British Crown in 1726. The treaties did not deal with surrender of lands and resources but in fact recognized Mi'kmaq and Wəlastəkwiyik (Maliseet) title and established the rules for what was to be an ongoing relationship between nations.

• Jacques Ouellette - Belledune ATV Trails Update

Mr. Ouellette presented to Council the history on development of ATV Trails, the status of the project to date, this issues that have halted the project from funding approvals to license of occupancy from the provincial departments. The Village of Belledune committed \$275,000 to the project and the balance yet to be accessed is \$131,800. Because of the delays on either the funding or the license of occupancy the cost of the bridge has now increased by about \$100,000 (in most part because of the steel prices increases created by the US steel tax). But the project is not dead, there is an application submitted to the Federal Gas Tax Fund - again hinged the license of occupancy approval from the province and as well to Belledune still prepared to committee the \$131,800. This trail and the bridge over Jacquet are not only important to Belledune but it is the ATV link for all northern N.B and the development of the ATV tourism industry.

 their input and recommendation.

 permitted term, so they can be given the opportunity to apply for the rezoning and have

the request come before Council, and go through the rezoning process for decision a Bylaw Amendment.
