Councillor, Adams Robinson

• Update on the hiring of the Public Works Labourer

There were 30 applications received and people are wondering what the status of the hiring is for this position.

It was suggested that with Mr. Lee starting tomorrow, it would be a good idea to bring this back to the Committee of Whole meeting.

• Update on Joint Health and Safety Committee

WorkSafe NB send a non-compliance in February and as well the need to establish a Joint Health and Safety Committee. That was incorrect, we do have one; Councillor, Carmichael was appointed to the Joint Health and Safety Committee last year, so where are we going with this.

Councillor, Carmichael said she is not up to speed on this and will discuss with CAO.

Mayor, Arseneault notes that last summer or even before that we had talked about committees, some has openings and others that had not done a lot, including our EMO, but we are starting to get a grip on that. It's really imperative sometimes that you have a full-time CAO in order to get those started; it is sometimes hard to get these things coordinated. We do have to do a much better job with committees and forming reports. We have to make a concerted effort that where ever our deficiencies are in our committees we need to start addressing them very seriously. In terms of committees, we have been threading a lot of water, unfortunately. These things happen and at least we are acknowledging that

these exist and we need to start bearing down and getting these committees straightened out and I think there is a commitment to do that.

Councillor, Bourque noted that work health and safety will probably be one of the most important issues that we have. In most cases it deals with our staff. Council do have a commitment to be there. Believe the superintendent in the past and administrative clerk-assistant have attended seminar. He asked if Nicole has attended one this year.

Nicole Carrier said that they hadn't attended for a number of years; there was no movement on the committee and that is part of Council's obligation and the CAO's. In 2002 a Joint Health & Safety Committee was established and meetings were held monthly until 2008. Council changed and hired a CAO and after that there was not much movement forward.

Councillor, Bourque confirmed that there were courses attended in the past and with Covid behind hopefully that will open up the province for those again and some training. He knows the staff reports to the CAO but Council is also responsible for the conditions our staff work in and he believes it is one of the most important committees we have to form and be informed on how things are progressing and the safety of our workers. For him, the sooner the better.

• Chaleur Bay Watershed Group

Addition of community representative to Board of Directors

Councillor, Robinson noted that with the changes from municipal reform and restructuring, Belledune is now allowed a second representative on the Chaleur Bay Watershed Group. She is the Council representative and we now need to have a citizen representative. Will we be advertising by Flyer or in the Newsletter.

It was suggested that this representation position be posted in the next Newsletter asking for interest.

Mayor, Arseneault noted his awareness of the Group was about three years ago and he was enlightened about the responsibility of that group and the importance they play regarding water.

RESOLUTION

RESOLVED, that as recommended by the municipal Clerk, the following resolution be adopted:

WHEREAS the Council of the municipality of Belledune has enacted a by-law pursuant to the authority of the *Building Code Administration Act*, S.N.B. 2020, c. 8, and amendments thereto, (the *"Building Code Administration Act"*), namely the *Building By-law*, and

1. it may from time to time be necessary to make orders for the administration of this By-law;

AND WHEREAS subsection 6.1 of the *Building By-law* provides that if work or demolition is undertaken in contravention of this By-law, the *Building Code Administration Act* or its regulations, the building inspector may make, in writing, one or more of the following orders: cessation of the construction or demolition work, alteration of the construction or demolition work to remove the contravention; and taking any other action required to make the building or real property safe;

NOW THEREFORE BE IT RESOLVED, that Yvon Frenette, Marcel Doiron and Stéphane Doucet, are hereby authorized to, when work or demolition is undertaken in contravention of this By-law, the *Building Code Administration Act* or its regulations, order the cessation of the construction or demolition work, alteration of the construction or demolition work to remove the contravention, and taking any other action required to make the building or real property safe, effective immediately, and this authorization shall continue until they cease to be an employee of the Chaleur Regional service commission or until rescinded by Council, whichever comes first.

2. it may from time to time be necessary to commence proceedings in the Provincial Court of New Brunswick, when a person has violated or failed to comply with this By-law;

AND WHEREAS paragraph 16(1) of the *Building Code Administration Act* provides that subject to subsection 16(2), for the purposes of Part 2 of the *Provincial Offences Procedure Act*, a person who violates or fails to comply with a provision of a building by-law or a regulation commits an offence punishable as indicate in the appendix 2 of this By-law;

NOW THEREFORE BE IT RESOLVED, that Yvon Frenette, Marcel Doiron and Stéphane Doucet are hereby authorized to lay informations on behalf of the municipality of Belledune in the Provincial Court of New Brunswick for violations of the *Building By-law*, the *Building Code Administration Act* or its regulations, effective immediately, and this authorization shall continue until they cease to be employees of the Chaleur Regional service commission or until it is rescinded by Council, whichever comes first.

The approval for now is for the use of the two vacant rooms (not Jack's Room) so the program can get started and to see where the youth want to go with this.

Councillor, Bourque congratulated Councillor Guitard-McDonnell on taking this on and he believes it is something required in our community and she deserves to be recognized for stepping forward and any time he can provide assistance, he believes Council should be on board as he believes it is critical to the development of our community.
