• Social and Environmental Grant- Jacquet River School

CAO Lee provided a brief summary that Councillor Bourque, although he had a scheduling conflict and could not attend the meeting, asked to have this item addressed for 2023. Councillor Robinson indicated that while budgeting for 2023, council did discuss allocating \$10,000 for Jacquet River School and \$5000 to the Breakfast Program, and suggesting moving the date for the report to the end of the school year. Deputy Mayor Carmichael acknowledged that \$10,000 was normally provided, but with the calendar year nearly over, she suggested the funds be broken out with \$2500 being provided in 2023 and more provided in January 2024. Councillor Guitard-McDonnell asked if the grant was previously provided in one lump sum or if it was separated. CAO Lee informed council that in previous years, the grant allocation was made in one payment after the motion was passed by council. CAO Lee reminded council there was approximately \$8700 remaining in the Grant budget, but if council did decide to contribute the full amount, budget could likely be re-allocated from another line item.
