Councillor, Duivenvoorden provided update on the May 19th Pub Night with a bit more details on financial status: Door raised \$130, half and half draw raised \$81, Band costs \$350 plus \$25 Bar tab - so the event had a loss of \$164. With other source of revenue the current financial status of the Pub Nights is \$183.25 deficit. This will be countered with this year's roadside cleanup fund of \$400. Pub Night could possibly be in jeopardy.
