MUNICIPAL BY-LAW NO. DRA-11-2017

VILLAGE OF BELLEDUNE BY-LAW DESIGNATING ROADS ACCESSIBLE TO
OFF-ROAD VEHICLES.

Pursuant to the powers conferred by the *Off-Road Vehicle Act*, S.N.B. 1985, c. O-1.5 and its amendments, the Council of the Village of Belledune duly assembled enacts as follows:

Definitions:

1. "Off-Road Vehicle" has the same meaning as defined in the *Off-Road Vehicle Act*.

General provisions:

2. No person shall drive an Off-Road Vehicle on the **Mutton Lane, Archibald Road, Mitchell Road, and Colony Road**, other than at the locations designated for this purpose and as further set out below and on a map attached to this By-Law as Schedule "A".
(Full map)
3. Off-Road Vehicle shall only be driven on the road of the **Mutton Lane** designated as municipal jurisdiction for a **distance of 2.3 km** and further set out on the map attached to this By-Law as Schedule "B".
4. Off-Road Vehicle shall only be driven on the road of **Mitchell Road** designated as municipal jurisdiction for a **distance of 579 meters** and further set out on the map attached to this by-law as Schedule B.
5. Off-Road Vehicle shall only be driven on the road of **Colony Road** designated as municipal jurisdiction, for a **distance of 10.74 km** and further set out on a map attached to this by-law as Schedule C.
6. Off-Road Vehicle shall only be driven on the road of **Archibald Road** designated as municipal jurisdictions for a distance of **3.9 km** and further set out on a map attached to this by-law as Schedule "D".
7. No person shall ride on the travel portion of **Mutton Lane, Archibald Road, Mitchell Road and Colony Road** with an Off-Road Vehicle at a location which is not designated to that effect.
8. The driver or any occupant of the Off-Road Vehicle shall be properly wearing a helmet that complies with the standards prescribed by Regulations under the *Motor Vehicle Act*.
9. The Off-Road Vehicle shall be outfitted with the necessary equipment as described in Section 22 and Section 23 of the *Off-Road Vehicle Act*.
10. Off-Road Vehicle shall operate in the same direction as traffic and travel in a single file to the extreme right of the road.

11. Off-Road Vehicle drivers shall give the appropriate signals as required under the *Motor Vehicle Act* and obey all traffic control devices.
12. Off-Road Vehicle drivers shall give the right of way to all other vehicles utilizing the roadway.

Offence:

13. Any person who violates sections 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, or 12 of this By-Law is guilty of an offence and is liable upon summary conviction to a fine of \$100.00.


Coming into force:

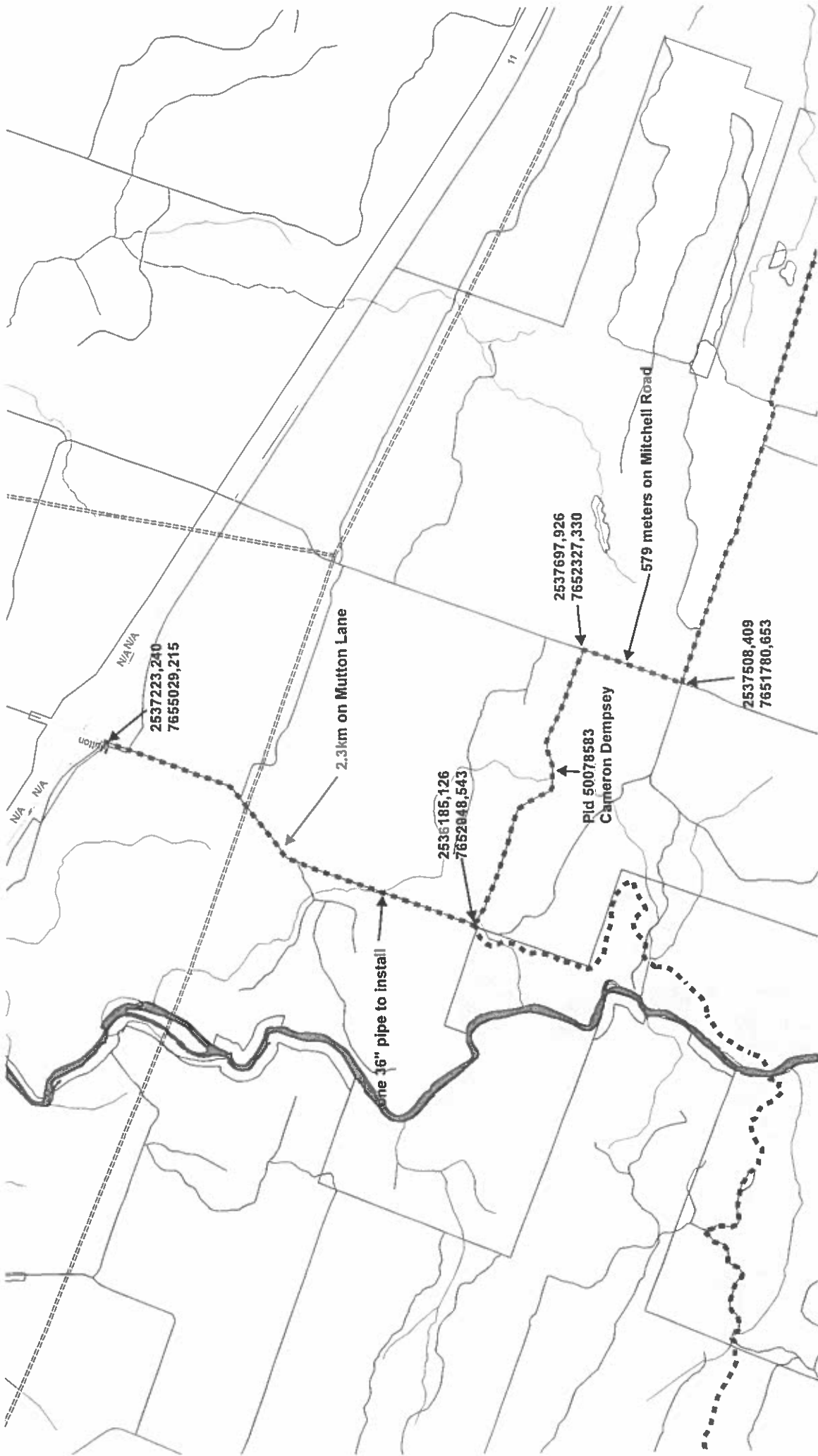

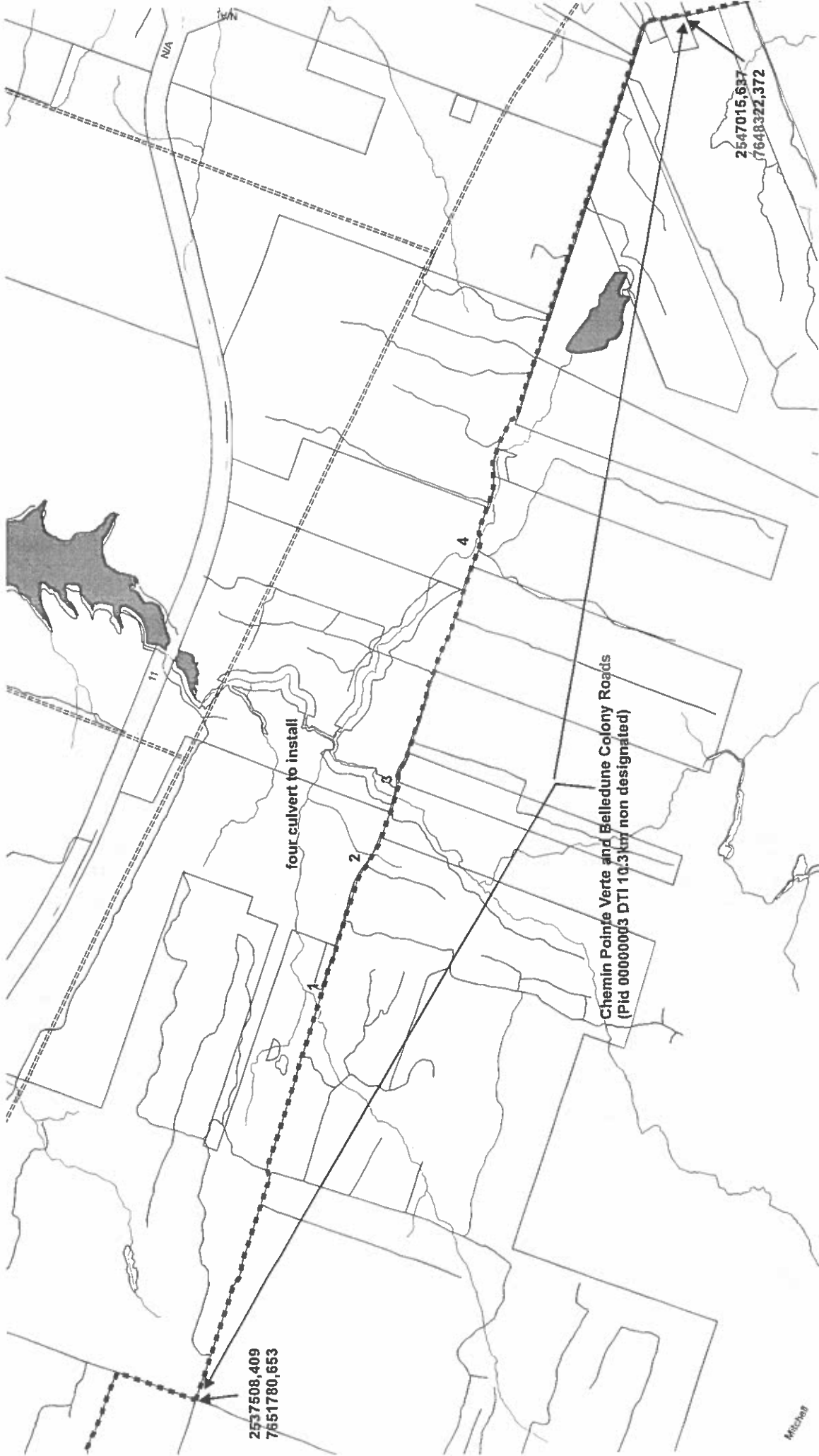
