

BY-LAW NO. 04-2019

**A BY-LAW RELATING TO THE ELECTION OF MEMBERS OF COUNCIL
AND THE ESTABLISHMENT OF WARD BOUNDARIES
WITHIN THE VILLAGE OF BELLEDUNE**

The Council of the Municipality of the Village of Belledune, duly assembled, under the authority vested in it by the Local Governance Act of New Brunswick, makes the following:

Election

1. (1) There shall be elected at each municipal election held in the Village of Belledune, a Mayor, one (1) Councillor for each ward, and three (3) Councillors at Large.

(2) The residents of each ward of the Village of Belledune shall at each municipal election for Mayor and Councillors held in the Village of Belledune, be entitled to vote for the Mayor, three (3) candidates nominated at Large and one (1) candidate nominated in their respective wards.

Wards

2. Within the territorial limits of the Village of Belledune there will be two (2) wards:

Ward 1- Jacquet River is described as follows:

“Beginning at the point where the southern banks or shores of Chaleur Bay meet the western boundary of Belledune; thence southwesterly and southeasterly along the various courses of the said western boundary to the western banks or shores of the Jacquet River; thence northeasterly along the various courses of the said western banks or shores to the southern boundary of Belledune; thence southeasterly along the said southern boundary to a point on the southwesterly prolongation of the eastern boundary of the former village called Village of Jacquet River; thence northeasterly along the said southwesterly prolongation and the said eastern boundary to the southern banks or shores of Chaleur Bay; thence northwesterly along the various courses of the said southern banks or shores to the place of beginning;”

Ward II - Belledune -Armstrong Brook, described as follows:

“Beginning at the point where the southern banks or shores of Chaleur Bay meet the eastern boundary of the former village called Village of Jacquet River; thence southwesterly along the said eastern boundary and its prolongation to the southern boundary of Belledune; thence easterly along the various courses of the said southern boundary to a point on the southwesterly prolongation of the western boundary of the former village called Village of Belledune; thence northeasterly along the said southwesterly prolongation and the said western boundary to the southern banks or shores of Chaleur Bay; thence northwesterly along the various courses of the said southern banks or shores to the place of beginning;” and
“Beginning at the point where the southern banks or shores of Chaleur Bay meet the western boundary of the former village called Village of Belledune; thence southwesterly

along the said western boundary and its prolongation to the southern boundary of Belledune; thence southeasterly and northeasterly along the various courses of the said southern boundary and the western boundary of Village de Pointe-Verte to the southern banks or shores of Chaleur Bay; thence northwesterly along the various courses of the said southern banks or shores to the place of beginning;"

Enactment

3. This By-Law shall be enacted on the date of the final reading by title, come into force according to Section 45 (3) and 45 (4) of the Local Governance Act by filing with the Municipal Electoral Officer.

Repeal

4. By-Law No. 11-2010, A By-Law Relating to the Election of Members of Council and the Establishment of Ward Boundaries in the Village of Belledune, enacted December 20, 2010 is repealed when the current by-law comes into force as outlined in 3 above.
