Understanding Emotion behind the Rhetoric

What is being said across the country:

- "The fact is the federal government is way too involved in our day to day lives to this day".
- "We have the abilities to run own affairs as sovereign nations."
- "Expand the powers that we have so as we can control our fishing rights, control our hunting rights, so as we can control our education so as to control our whole destiny through our political initiatives."
- "Now listen to that expand the powers we have today we have power. We have the power to shut Canada down and force them back to the negotiating table. What we need is an organization willing to step up to the plate and be that original body."
- "What we should be fighting for is a different way of getting paid from the government what they owe us is back taxes on our land,"
- "We should be collecting flat percentage rate of all that's raised through taxation, resource extraction, Crown land leases – every fund they have, there should be a flat rate percentage of these fees paid to us — and retroactive. The funds should be monitored and paid out by our own governance board and shouldn't be considered government funding, but rather land resource use payments."
- "New Brunswick is unceded/unsurrendered traditional First Nation traditional territory".

Events like Supreme Court rulings, TRC, the United Nations Declaration on the Rights of Indigenous Peoples and the willingness by Governments, organizations, businesses and educational institutes to pursue reconciliation, makes it an opportune time for an action strategy by FN`s in a movement toward partnerships with all levels of Government and private sector proponents in promoting economic development in our traditional territory.

Too much time is spent on defining self government and forms of sovereignty with limited results. Our strategy calls for solid governance structures in place and resulting in strong community support. It is a way of empowering people at the community level and re-instilling cultural pride.

Rather than discussion and studies to determine self government this Pabineau First Nation strategy is part of an action plan moving forward.






Strategic Planning – Must be Inclusive

Declaration of Title and Rights over Traditional Territory



- Describes Aboriginal title and inherent right as Stewards over traditional territory in the case of unceded/unsuurendered land
- Outlines system of governance over lands and people
- Clear statement on strategic alliances and development of resources on First Nation terms and priorities as Stewards of the land
- Developed with input from Elders and community members



Consultation Protocol

- One of the more important components of the Strategy
- Incorporates the spirit and intent of development in traditional territory
- A mandate that must come from community members
- Outlines the terms and conditions set by community members for elected officials entering into discussions on resource development and other decisions impacting on the FN lands and people
- Elected officials accountable to the people
- Ideally signed by all community members
- Establishes strong bargaining position because force of the people behind elected officials


Overview of the Structure

- PFN Economic Development Corporation is the general partner with its own Board of Directors with the responsibility of managing the Limited Partnership
- PFN is the limited partner and entitled to receive profits and distributions from the limited partnership and the operating LPs.
- PFN is the sole shareholder of the PFN Economic Development Corporation. As such, the PFN Economic Development Corporation reports to and remains accountable to PFN Council and Community.
- Structure provides for a collaborative working relationship with necessary expertise required to identify and pursue economic opportunities that reflect and respect PFN's history, culture and values.






Pabineau First Nation exciting future in partnership

Govts & Other Stakeholoders

- Objective is to have FN move to the left and objective of FN is to have Govts and other stakeholders move to the right
- Court recognition of Aboriginal title and Consultation Protocol establish strong pressure on Govts and stakeholders to move to the right
- Movement to extreme right constrained by what is possible under Canadian Constitution but not impossible as Constitution can be changed with consent of provinces
- Strategy is to work collaboratively along range
