Mayor, Noel

• Day Care Presentation Report - Next Steps

Mayor Noel made note of public meeting regarding Day Care Services and gave a brief overview of Deputy Mayor, Killoran's presentation.

Councillor, Arseneault

• Fire Station #1 - Renovations of Rental Space

Councillor, Arseneault discussed the tenant at the facility and the proposed rental rate increase by \$500. He would like this evaluated further and feels the increase is quite high. He would like to have this discussed further.

Mayor, Noel noted the increase in rental fees is in relation to the costs of renovations.

• New Arena Family Rate

Councillor, Arseneault will be bringing forth a motion to change the family rental rate approved in January to a lesser rate - that would come into effect the next season, say starting in July.

• Snow Plowing Operations

Councillor, Arseneault would like to evaluate the snow removal services to see if there is a way to have a third-tier service for those storms that have streets blocked for several days. We now have DTI and then DTI hires contractors when then cannot handle alone. He would like to evaluate a plan that would use a third option to assist when they are beyond their capacity. He is proposing to have a Committee with himself as Chair a couple of citizens and the Clerk/Treasurer and any other Council member who may want to participate. There would be not commitments or monies expended, just some evaluation to see if there is any way to increase service delivery during the sever storms that leave streets blocked for several days.

Mayor, Noel advised that the formation of a Committee would have to be done with a By-law but feels that it may be a good exercise.

• Pub Night Reports

Councillor, Duivenvoorden reviewed the Finances of the December 2018 and February 2019 Pub Nights.

December starting balance \$221.15 - Revenues \$85 at the door, \$49 for 50/50 draw, expense cash prize open mic night \$100, winner gave back \$60 - Balance at end \$335.15.

February starting balance \$335.15 - Revenue \$95 at the door, \$70.50 for 50/50 - expense band \$350.00, roses \$46.55, other supplies \$26.50 plus band bar tap - Balance at end \$12.60.

• Maritime Iron - Meetings with local residents

Councillor, Duivenvoorden discussed the meeting held by Maritime Iron Inc. with residents of Chaleur Dr., Hodgins Road and Curry Dr., which Council was not invited. He is hopeful that the meeting provided opportunity for discussion and it would have been nice to get some feedback. He hopes that there can be a balance between accommodating the residents and the plant. The balance has to be there to retain the residence and see the plant come to fruition.

Mayor, Noel clarified that from the first pubic meeting, the company got a feeling that some citizens would like to discuss a bit more, but were not comfortable in that public forum. The company opted to give them that opportunity through this method of meetings with those citizens.

Councillor, Arseneault spoke about possible training through CCNB for the jobs. But the types of jobs would need to be known so that training may be established.

Councillor, Culligan and Mayor, Noel briefed on the meeting they had with CCNB (Bathurst & Campbellton) regarding exactly this. Councillor, Culligan has now been tasked with getting the information of types of jobs and training needs.

She also, took the opportunity to talk about the current training centre in Belledune with only 4 students attending this year. She noted that without the basics of a high school diploma or equivalent, these other trainings and jobs will be out of reach. She encouraged everyone to promote the local service as with any government, when cutbacks are being looked at, they will look to those that are under utilized.
