Belledune Festivals

# Councillor, Duivenvoorden

• Belledune River Outlet

Councillor, Duivenvoorden met with Paul Fournier (DOE) regarding the dredging of channel and it is a complicated issue, requiring DFO approval as well. There need to be many steps completed to move this item forward; land title established, draft plan, permit, project proponent, determine who will do and a detailed plan for DFO (would require consulting services and big money). He will follow up with DFO.

• 13 Ways to Kill your Community - Presentation

Councillor, Duivenvoorden advised that he attended the session in Campbellton on November 27, 2017. Municipalities were represented from Kedgwick to Belledune. It was a no holds barred presentation, very informative and in plain language. The presenter has a book of the same name, which he bought and intends to read.

• Advisory of an official reaction to Council's decision to not amend Rural Plan By-law to make us more food producing friendly.

Councillor, Duivenvoorden noted he has no intention to open the debate on this matter, nor to slight any members of Council, but wish to respond on this matter and express his disappointment on the decision to not approve the amendment of the Rural Plan for Agriculture Uses.

Points of discussion included:

- Four (4) reasons why people make decisions
- Some counter points to Councillor, Culligan's presentation in October and clarification on the role of Dept. of Agriculture is to promote agriculture
- Farming industry and aging operators and reasons younger generation not interested in farming
- Impacts on food supply

#### • Invitations Protocol

Councillor, Duivenvoorden noted that there are many invitation of various function that get distributed and there does not seem to be any protocol on who goes or does not go. Most would have an expense component applied to them. He suggested that maybe they could be streamlined and go to the Mayor and then if necessary distributed from there.

Mayor, Noel recommended that CAO, Lee check to see what other communities do.

#### Councillor, Killoran

• Finance Committee - Chair 2018 Budget

Councillor, Killoran - Finance Committee Chair made a PowerPoint presentation entitled Budget 2018 - Belledune Finance Committee. A copy of the report is on file.

He also noted that a public presentation of the entire Budget will made once the it received provincial approval.

There was discussion by Council on additional remuneration for the Finance Committee work, adding \$250 to the December remuneration. This did not proceed.

CAO, Lee noted he is working on the policy regarding staff and will be coming back with recommendations to Council for amendments to consider regarding the extra time spent for after hour meeting such at these.

Mayor, Noel noted the Finance Committee will be targeting 2019 Budget meetings to start in September versus November.
