Housing Initiatives

To address their issues, St. Francoise incentive to fill some of the employment vacancies in their community, was used as example of what can be done. Belledune should really look at doing some incentives to increase population and address house sales. In a meeting with CAO, Lee, Councillor, Duivenvoorden recommended he should draft something for Council to review and consider. Timing is critical and something should be done now.

• Donations - How they are Handled

Councillor, Duivenvoorden expressed his concerns over how the donation requests are being handled; they are all over the place with no consistency. His preference would be for the staff to handle the donation requests, based on a clearer policy with a proposal or report coming back to Council.

Council deliberations included discussion on Council Committee versus Administrative roles, Council responsibility as policy makers and Administration responsibility to implement.

The Donation Committee (Councillor's Duivenvoorden and Killoran) did not review the current requests and there is no recommendation ready for Council decision.

Council determined they would review the list of requests for this evening one by one and make decisions.

The directive to CAO, Lee further investigate what other municipalities are doing, create a clearer policy and procedure for adoption by Council with the intent of having Administration handle the donation requests and report back to Council.

WHEREAS the council has adopted a dangerous and/or unsightly premises by-law being BY-LAW # DUP 09-2011, A BY-LAW OF THE VILLAGE OF BELLEDUNE RESPECTING DANGEROUS AND / OR UNSIGHTLY PREMISES)

AND WHEREAS the municipality must ensure their proper administration and the personnel from the Regional Services Commission has agreed to provide enforcement;

NOW THEREFORE BE IT RESOLVED that the following persons are hereby appointed to act for and on behalf of the municipality in order to properly enforce the dangerous and/or unsightly premises by-law being BY-LAW # DUP 09-2011, A BY-LAW OF THE VILLAGE OF BELLEDUNE RESPECTING DANGEROUS AND / OR UNSIGHTLY PREMISES pursuant to the municipality's authority outlined below:

BE IT FURTHER RESOLVED THAT the above-noted appointments are subject to the following: 102.1(1) and 190.01(3) of the Municipalities Act, in order to enter upon property at all reasonable times and issue notices for dangerous or unsightly premises;

BE IT FURTHER RESOLVED THAT the persons appointed above exercise their discretion in accordance with the files provided by the municipality and in accordance with applicable municipal policies;
