

# Village of Belledune Council Working Session May 13, 2019

The following items were on the Agenda of the May 13, 2019 Working Session and discussed.

# Regional Policing Update

Mayor, Noel and Bathurst Mayor met with the Ministers of Environment & Local Government and Public Safety regarding the regional policing study by CRSC. Both Ministers have reviewed and both like the proposal. They will not be conducting a study of their own in this region for policing, as they suspect the results will be the same. They will assign someone to work with CRSC to proceed with the proposal. The funding formula 50/50 cost share is something that will be looked at in the future. As for Belledune in the CRSC regional police proposal, we should see a reduction in the costs the 3<sup>rd</sup>; the change will depend on calls. The CRSC Proposal will also included rental for the office space in Belledune. The main office will be in Bathurst and sub-stations in Petit Rocher and Belledune. The proposal could be approved within the year.

Directive to CAO, Lee was to have CLAD proceed with giving a price on the scope of work for the Policing Room in the east end of the building. It will be brought forward with the other proposals for Monday Regular Meeting.

#### Management Letter of Recommendation

The two items identified need to have some solution developed. They will be addressed in policy revisions and communications.

Administration will be working on the By-laws and Policies to prioritize, review, update and create new one where needed.

#### July & August Meetings

Proposing to have the July and August Meetings cancelled. If necessary, can call a Special Meeting.

Directive: Add the motion to the agenda for Monday Regular Meeting.

## Resident Complaint Archibald Rd.- Water

This issue has been looked at for the past several years, and the water is not created by the municipal ditch, but from the back end of the property.

Directive to CAO, Lee to send letter to property owner

## Resident Complaint Noel Rd. - Drainage issue private property

This issue was evaluated by engineers on several occasions and is not created by the municipality, but by the private property. Engineer's estimate provided to fix private property issue is approximately \$100.000.

Directive to CAO, Lee is to discuss with engineer again and report back and respond to resident with a letter.

# Residential Grants Policy

Clarification on the Policy regarding criterion and who qualifies.

Directive to CAO, Lee to create a criterion and documents list so that when applications are received, he has some measurement tools to review and make recommendation from and applicants know what they need to qualify and nee to provide when making application.

## Campground Opening

Inquiry about employee start up

Directive CAO, Lee will be organizing a meeting with all the seasonal employees to discuss various matters.

## Arena Summer Opening

Questions regarding the cost of operations for summer operations, the wear and tear on the equipment due to summer operations and the possibility of breakdown with costly repairs. As well, the operational hours vs. employment hours - where employees want a 40-hour week.

The question of no formal commitment, by Motion of Council to open this year; previous year was a test year.

Directives to CAO, Lee and Clerk/Treasurer, Cormier to prepare some reports to include on the agenda; which, will accompany a proposed motion to Open or Not Open.

- Tourism Seasonal Work Subsidizing Gorge Rental Space Super Village General discussion on why these items have to remain and be supported by the Village. It was noted that Belledune needs a Tourism Strategy of its own.

Arena Employee - Working Hours (lack thereof)

This was discussed previously and the fact that the employees are not able to get 40 hours during the summer season because of reduced ice rental hours. Not sure of solution.

Directive to CAO, Lee is to have Mr. Bouffard do a follow up report for Council on the ones that are currently in the system and to advise him of others identified.

Technology Upgrades - Council Chambers

Accommodate Remote Meeting Attendance

The cost associated with doing this to accommodate accessing a meeting remotely is very expensive. Given the very few times this would occur and if Council are respectful of sensitive issues and if someone is going to miss a meeting, they could make a prior request to Council members, to consider tabling the issue to a subsequent meeting.

Consensus was to not consider equipment purchase at this time.

Directive to Clerk/Treasurer, Cormier to not proceed with preparing amendment to Procedural By-law to allow attending meetings remotely, as equipment will not be purchased.

CLAD Proposals - Café and Office Renovations

CAO, Lee reviewed the west wing renovation and provided CLAD proposals and will have some others prepared by CLAD with options and will bring forward to the Regular Meeting for motion. In addition, the Policing Room, which was designed in Phase 1, will need a proposal from CLAD regarding their cost to manage that renovations process.
