Mayor, Arseneault felt that a lot of new information came out of the Town Hall session from the guest speakers. He felt that the best commentary of the evening was from Jim Richardson of Papineau First Nations regarding social responsibility and inclusion. He feels that the people are frustrated with the process that has been used up until now, and he feels that a large part of that was due to lack of public consultation. If we acquire First Nation's consultation, we will have a better opportunity to make the right decision for everyone in the community. Mayor, Arseneault would like to see a hold put on the work until we have received First Nation's consultation or begin the process of obtaining First Nation's consultation while we're gathering the information to make a proper decision moving forward. Councillor, Bourque commented that Mayor, Arseneault is not able to make motions, so he put the motion forward.

• Upcoming Meeting with Ministers

Mayor, Arseneault said that the Chaleur Regional Service Commission had a meeting with Minister Kennedy of Environment and Local Government, of which the Village of Belledune was involved in that discussion. It was about how the communities, post amalgamation, can work together to be a stronger entity. Chief Richardson has been working to help the Village of Belledune to get meetings with Ministers. We have a clear path to Ministers that we didn't have in the past, in large part to the work of Chief Richardson and Marco LeBlanc.

• CRSC Update

Mayor, Aresneault wants the public to know that the Service Commission is an important entity and you should become more familiar with it. As more substantial things come up he will relay them.

• Martin Luther King Jr. Day and National Literacy Day

Mayor, Arseneault said that Martin Luther King Jr. Day and National Literacy Day are important at Jacquet River School, which is why he's bringing them forward. Martin Luther King Jr. Day is a reminder of why it's important to put all of our differences aside as much as we can.
