• Belledune Broadband - Memorandum of Understanding (MOU), Rock Network Inc. & Village of Belledune

CAO Lee provided a brief overview of the revised MOU. In discussions with Andre Daigle, municipal lawyer, the original MOU had been drafted to ensure ROCK Networks be named the Network Operator, should the project be successful in securing funding, and the Council of the day choose to move the project forward. Andre has suggested that this designation could be contradictory to the Provincial regulations around procurement, and recommended that the MOU not read that ROCK Networks be guaranteed this service. As a compromise, ROCK Networks requested that the MOU specify that the data they have collected and business case studies they have compiled for the application package for the Universal Broadband Fund be considered their intellectual property. In Andre's opinion, with the information he has on this MOU, he feels it does not commit this Council or subsequent councils to the project.
