Roherty Road

Councillor, Guitard-McDonnell referred to the discussion at the In Camera meeting and what is the best option - chip seal or paving. The consensus seems to be leaning towards paving and she will put a motion forward on September 19, 2022.

Councillor, Carmichael noted that chip seal may only last a few years and while paving will cost more it will be a long-term solution.

Councillor, Robinson noted she has a hard time to justify \$100,000 extra for paving when there are more pressing issues and a lot more infrastructure that needs repairs.

Councillor, Carrier noted she is hearing what Councillor, Robinson is saying, but there is not much money being spent in this area. This is the only public beach access and is an asset. Prices go up and will continue to go up. We have been here a year and there have been benches and lights put up for the Veteran's Park.

Deputy Mayor, Bourque said he agrees with everyone's comments and \$100.000 more, is a concern. Council has failed to do a Strategic Plan. He firmly believes the community cannot move ahead by counting pennies; we have to look at the long term. This Council will only be the beginning at looking at difficult decisions - budgets, increases for RCMP. Paving Roherty Road which will be utilized 3-4 months and it will not deterioration will not be as dramatic as it is not used in winter. This will be a positive direction.
