Resolution

WHEREAS the council has adopted By-law DUP 09-2011 entitled a *By-law of the Village of Belledune respecting dangerous and/or unsightly premises*;

WHEREAS the *Municipalities Act* sections dealing with dangerous or unsightly premises provides for an appeal before a committee of council;

NOW THEREFORE BE IT RESOLVED that council establishes the appeal committee which has the authority to deal with appeals resulting from the issuance of a notice to comply for a dangerous or unsightly premise, and the committee will decide on appeals that are filed in accordance with section 190.021 of the *Municipalities Act*;

BE IT FURTHER RESOLVED that this committee is composed of members of the Regional Planning Advisory Committee of which Belledune is member. Appeals must be heard by a minimum of 3 people chosen by the chairperson of the committee to hear a particular appeal;

BE IT FURTHER RESOLVED that council adopts the Operating procedures of the dangerous and unsightly premises appeal committee dated November 2017. The appeal committee must inform council of any significant changes that would affect these operating procedures.
