#### **Business**

CAO - Letter of Offer

Councillor, Robison noted that Council had met last Thursday for over an hour to discuss the terms and details of the contract for CAO. After a bunch of calls and e-mail over the weekend that agreement is changed. She does not think this could in a legal manner be done without a meeting of Council. She wants people to know it is business as usual in Belledune.

Councillor, Guitard-McDonnell said she made no phone calls, but rethought everything and decided to bring forward those changes and were the proper ones in her mind to treat the CAO as an employee rather than a contract position. She researched and the probationary period is normally three months in New Brunswick and not six months and where this person held the position in the past the six months probation is not necessary.

Councillor, Carrier wanted to know why after the discussion was had and we agreed on and she recalled it was Councillor Guitard-McDonnell who mentioned the three months. Another thing is we paid for training we paid for someone to specifically come here to train us on this sort of thing. He trained us and told us specifically that each Council member should be open to hiring the CAO they felt is the best qualified and experienced in what their strategic plan is and which is why CAO's are often hired on a contract basis to give the next Council to come in and once they have their vision hired the CAO with the expertise to make that plan happen. It almost appears to her that the discussion Council has was brought back to Mr. Lee and he was unsatisfied to what Council agreed on and then Council members starting e-mail back and forth and boom, boom, boom. Even when there were questions answered I asked if Council considered taking Mr. Lee in and discussing the terms of the contract, no one even responded to that. Why would we be having a meeting about a letter when the letter has not even been finalized by legal or Council and there was no response to that. It just seems everything is just being pushed forward. The more things change the more they stay the same and it is unfortunate that those of us living here are hoping for a better place.

Councillor, Bourque noted that the democracy is a great thing, we get to express our views. It never going to be that everyone agrees with everyone on every single thing. When the time comes to vote it is based on majority vote and that is where we are. Personally, I have been part of many votes that have been voted down and I can assure you not one word did I ever say or argue with Council over it. Because we disagree does not mean that someone is right and someone is wrong, it means we had a difference of opinion and that difference of opinion needs to be respected by the majority of Council and once the voted is done that is it.

Councillor, Carmichael said it was s difficult process and we worked hard together to get it done. I just feel he will do an amazing job and not everyone is going to agree. Once the vote of Council is decided that is the vote it should move on; the past is the past and we have to move forward

Councillor, Carrier asked Councillor, Bourque if he had now changed his mind on the audit considering that Mr. Lee was the project coordinator and manager for that project. She is wondering if his opinion on that has changed being as you want to hire him back. You must think he did an awesome job.
