STATEMENTS BY MEMBER OF COUNCIL

Deputy Mayor Bourque

• MEETING MOST BEAUTIFUL BAYS IN THE WORLD

Deputy Mayor, Bourque said he was asked to go to a meeting, as Mayor Arseneault could not make it, for the Most Beautiful Bays in the World. There was 6 Mayors of the region and the president, Louis Thibeaux, from France. Discussion was in regards to what can be done to promote the Bay of Chaleur, how and where. The organization represents 44 bays in the world. Deputy Mayor, Bourque is asking for his mileage to be paid and for ½ day per diem, looking for a motion of Council to approve his expense.

Councillor, Carmichael asked where the meeting was held.

Deputy Mayor, Bourque said it was held in Charlo.

Councillor, Carmichael said she attended many meetings before and never submitted a per diem. She thought if it was in the area there was no per diem given.

Councillor, Carrier said she thought she seen where it was so many kms out of the area. However, she was not sure, she asked Assistant Clerk, Carrier is she knew.

Assistant Clerk, Carrier said that she was not certain, however nobody had asked for a per diem in the past when it was it the region. She would have to check to be certain.

Councillor, Carrier suggested that this gets tabled, and have all the information before a decision is made.

Deputy Mayor Bourque said that there is a motion on the floor, he asked for a seconder - Cynthia Robinson. MOTION CARRIED. (Note: there was no motion moved by anyone, so no motion exists)

• INSURANCE FOR MARK ARSENEAULT'S TOURNAMENT

(Mayor, Arseneault said he stepped out)

Deputy Mayor, Bourque said he had received some information in regards to the insurance coverage for Mark Arseneault's hockey tournament. He said the form was about 7 or 8 pages long, he filled it out and received a quote back of \$732. That amount does not cover the cost of the insurance for the canteen. He is still waiting for the amount.

Councillor, Guitard-McDonnell asked if this was ever an issue before that he needed insurance.

Deputy Mayor, Bourque said no and he does not know why or how this came about.

Councillor, Guitard-McDonnell asked where the money to pay the insurance will come from.

Deputy Mayor, Bourque went on to say it would have to come out of the budget, but not sure where, he went on to explain about the year end amounts being transferred, etc. He mentioned that if there was a CAO in place, they would be able to approve it, and it would just be taken out of the budget. However, without a CAO in place Council has to approve for the payment to be made.

Deputy Mayor, Bourque went on to explain all the expenses that Mr. Arseneault has. He does get a break on the ice rental, and \$395 for the program paid for by the Village. This year the cost of the program has doubled and is \$800, due to inflation and of course parts of the program is in color. There are a lot more cost involved, such as buses, music every night, magic show on Saturday, etc. He said that in the 16 years he has been involved that insurance was never an issue.

Councillor, Carmichael mentioned that if the insurance is not covered Mr. Arseneault will probably not have the tournament.

Deputy Mayor, Bourque said he couldn't speak for Mr. Arseneault. But he feels the issue is that this tournament is well organized and is very popular. He also feels that there has to be canteen services. He said that this was in the hands of the Council.

Councillor, Carrier asked when the tournament was, its March 20, to April 2. She would like to have more information before a decision is made.

Deputy Mayor, Bourque said he would pass on the request and would forward the information that he received in regards to the insurance.

Councillor, Carrier asked if this would be considered a village event since we are giving out money and paying insurance cost.

Assistant Clerk, Carrier explained for it to be a village event, any monies made would have to come back to the village. She also mentioned that the insurance was never an issue because there was never a request for the village to cover the cost. She explained that figure skating and minor hockey groups all have their own insurance, in other areas even the old timers' leagues, for example, have to carry their own insurance. This was something that came up in previous years, however nothing was done about it. So, when our insurance company was sent the request to have insurance for the canteen during an individual's hockey tournament, the insurance company said what was required and that the village's insurance could not cover the cost as it is not a village event. The canteen is a private business and Mr. Arseneault is an individual putting

on a tournament on his own. That is how this all came about. The village's insurance company is there to protect the village.

Councillor, Carrier said she would like to see what the expenses and sponsors are for the tournament before deciding.

The directive was given to Assistant Clerk, Carrier to ask Mr. Arseneault for this information.

Councillor, Carrier said maybe he could cut cost by not printing the program in color.
