Mayor, Arseneault

• Update on Dangerous and Unsightly Appeals Committee

Mayor Arseneault senses that there is frustration in the community with the speed and process for determining unsightly premises and, once determined, the process for having the property cleaned up or taken down. Mayor Arseneault feels that this is something that needs to be addressed. Mayor Arseneault doesn't feel that we are moving forward as quickly as we should be. He feels that we can do a better job of getting these premises highlighted and dealt with. Mayor Arseneault feels that for the remainder of Council's mandate they need to push to get these premises cleaned up or torn down. Mayor Arsenault acknowledges that the lack of an Appeals Committee has been a hinderance on moving forward with these properties. He is looking for an update from CAO Lee and wants the people watching to spread the word that we are trying to get some of these premises dealt with.

CAO Lee said that Council had started a process with some properties that were identified, and there is a resolution on the agenda for a property that needs to be actioned, so he may speak to this more when we get to that item. CAO Lee indicated that when there are properties that are identified, Council has the ability to identify properties, but it is the Service Commission who is the by-law enforcement officer, and it's the by-law enforcement officer who receives complaints and goes out to evaluate the property and they can start the process. When an order is issued, one of the legislated components of the order is that the resident has the opportunity to appeal. Looking at the files that Council was working on previously, of the six orders that were issued five of them received an appeal. The bottleneck in this situation was that Belledune did not have an Appeals Committee in place. We have advertised for it asking interested residents to submit resumes. We need a committee of about four people and we currently have two people confirmed. We still need at least two more people for this committee. and then there is training that will need to be done to ensure the committee members are fully aware of their roles and responsibilities.

Councillor Bourque indicated that several years ago the Committee was at the Regional Service Commission. Five residences were torn down during that time. Councillor Bourque feels now that the Appeals Committee needs to be in Belledune we have the onus of people making decisions on properties belonging to friends/family members. When the Appeals Committee was in place through the Regional Service Commission, four residences were torn down by the Village of Belledune in conjunction with the Appeals Committee, the expense was sent to the Province, the Province reimbursed the Village and issued a lien on the property to the property owner. Councillor Bourque wants the citizens of the Village to know that if they want to clean up the community, they need to step forward. The citizens need to realize that this can not be done without an Appeals Committee Councillor Guitard-McDonnell asked CAO Lee about the five properties that went through the appeals process and how long we have to sit on that. CAO Lee informed Councillor Guitard-McDonnell that the appeal has to be overviewed by the Appeals Committee.
