- Allan Roy Flag Request

- John Young (River Road) Safety Concern (Accessing Route #134)

Mayor, Noel advised that this was addressed by previous Council and submitted to DTI and to the Planning Branch in Fredericton. It has been brought forward before and DTI will review and make decision, as Route #134 is under their jurisdiction.

- Don Gallen Inquiry
  - The issue was power outage because of NB Power transformer and the municipal utility operator responded made the necessary calls and the problem were repaired in a timely manner.
- Moose Fence Route #11
  - There are concerns and complaints and there needs to be something done. A letter to DTI or something else to address the concerns.

Mayor, Noel advised he had been in discussions with MLA, Daniel Guitard and DTI representative, Daniel Leblanc. There are looking at getting money to repair. He has calculated what it would cost to repair and given that amount to them. They have advised they will seek the funding to repair this year and the replacement of the electro braid fence with the traditional fencing is slated for 2019.

A motion will be on the agenda for the Regular meeting to submit a letter asking for replacement in 2018.
