## **Council Report for January 2022----- Report #1**

**The Council of the Village of Belledune extend to you our sincere hope for a very happy and prosperous new year. The purpose of these reports will be so all who read them will have a clear and transparent idea of what is happening in your community. The “Messenger” will carry a monthly report so that you have accurate and up to date information on how Council will direct our community in, for future growth. Each month I will highlight the decisions of Council so that you are informed on the most important issues facing our community and what Council has decided to do to address these situations. This report will highlight the progress made for the first six months of our term. Each report there after will cover the issues of that month. I will ask that if you should have any questions concerning anything in this report, please contact a member of Council who will answer your concerns. Council will also request that any ideas on economical growth, tourism and job creation will greatly be appreciated and considered by this Council. For this report I will present the issues as follows.**

- Council has had several training courses on the weekends that were done by experts in municipal politics. They include Municipal Governance, Legal Issues and Conflict of Interest done by our legal council Andre Daigle. Council also did some training from Mr. Jack Novak who is an expert on municipal government, role of Council, Council Management Systems and Rational Planning. Our training sessions concluded with Mr. Don Smeltzer providing more information on Codes of Conduct and the Committee structure that many Councils use to move their communities forward.**
- Our Council began with a “Portfolio” process; however, this has now changed to a “Committee” format. All members of Council chair a specific committee and all members of Council can attend any committee meeting. Each Council Committee Chair person is responsible for the clear information of their committee being presented to the balance of Council so that when motions are presented, all the information is evident.**
- The budget for 2022 was a learning process for the new members of Council. I am very happy to say that after 6 meetings the budget was approved and forwarded to the province for approval. Our first budget was approved and all that remains to finalize are the Capital Expenditure projects we wish to do in 2022.**
- Council was faced with finding a new Chief Administrative Officer (C.A.O.) in early July after the resignation of Landon Lee. The C.A.O. is responsible for all employees working for our village and he/she reports only to Council. Council needed an interim C.A.O. and Mr. Scott Ferguson was chosen by Council to fill the position. Council has now appointed a committee to find a permanent C.A.O. and that process should be completed in early 2022. The committee consist of Mr. Deny Caron (Port of Belledune), Mr. Jack Novak as mentioned earlier, Mayor Paul Arseneault, Councillors Cynthia Robinson and Lilliane Carmichael and Mr. Gordon McDougall (former principal of Jacquet River School).**
- Council has had many discussions concerning areas of concern to the future economical development growth of Belledune. The areas of concern are zoning for the development of Antiques Plus. This business is critical to the growth within our community and Council is now working on the Re-Zoning plan for the future development of this great business opportunity. The development of AJN Investments within our industrial park**

will help reduce future unemployment in our community. Council has already approved the development of a road extension to Restigouche Road so they can access the property where their manufacturing facility will be built. This manufacturer has been approved for funding from ACOA and is in the process of trying to finalize details to begin building their new plant.

- I would like to highlight some of the very positive things that have distinguished our community from many others over the last six months. Belledune hosted the President and C.E.O. of N.B. Power, Mr. Keith Kronkite who was accompanied by the Chairman of the Board of N.B. Power, Mr. Charles Firlotte. Mayor Paul Arseneault provided the driving force behind this very positive information session. This was a major accomplishment for Belledune to have these two individuals shed some light on the future of N.B. Power in Belledune. It is confirmed that our plant will not burn coal past 2030. Some of the ideas discussed were pellets to replace coal or SMR (Small Modular Reactors) to be built out of the facility. Many strong business minds were present and a very positive approach is being developed with both first nations in our area.
- Belledune hosted a flag raising ceremony where our municipality now has the Indigenous flag flying on our flag pole at the municipal office. Chief Terry Richardson of the Papineau First Nations along with 60-75 first nation people were present for the flag raising ceremony. Our relationship with the first nations is extremely strong and will help in the development of business and public relations.
- The snow removal from streets that the Village of Belledune is responsible for has now been completed. There are still some details that will be required to be completed by the local contractors who will do the work after a major storm. The contractors will only be requested to blow snow after a storm has dropped 25 cm of snow or more. The contractor will only blow the snow that is in the driving lanes of a street. They will be required to make one cut up the street and one cut down the street. The contractors will only blow snow when requested to do so by the Village of Belledune. The purpose of this program is because our community has experienced delays in cleaning the side streets by the Department of Transport. The D.T.I. cleaning of our side streets will continue; however, this process should help in getting people out of their driveways more quickly. This will help in an emergency or to allow people to get to work because their street is clear from snow a day sooner.

In closing this report, please continue to follow Councils' progress on YOUTUBE and if there are any helpful suggestions on making Belledune a better place for all, contact any of your elected officials at any time.

### **Garbage and Recycling Collection Notice**

Please note a few items in regards to the Collection of Recycling and Garbage:

- We are asking people to put their recycling bins out when it is  $\frac{3}{4}$  full, when people wait until it's full or overflowing it causes issues with the truck lift. Thank you for helping us out.
- The bins (or garbage bags) must be put out by 8:00am

- Garbage/Recycling bins or bags must be put at the end of the driveway on the shoulder of the road, some people are putting their bins half way up their driveways, if it is not at the end of the driveway, we will not be picking it up

SNOW REMOVAL PRACTICES: Offence subject to Disciplinary Action

Violations under the Belledune Traffic Regulation By-law – By-law #: TR-11-2003 - A BY-LAW OF THE MUNICIPALITY OF BELLEDUNE TO REGULATE TRAFFIC.

SNOW OR ICE ON STREETS

No person shall place snow or ice upon any street, sidewalk or square in such manner that impedes or is likely to impede movement of traffic or pedestrians. (Section 69, Highway Act)

Please Note – it is very dangerous for people to put their snow on the road, and it is illegal. Whether you live on the main road or side streets, do no put your snow on the road.

Special Notice – Ditches and Culverts

Prior to doing any work on Village property, such as filling in ditches, installing culverts, etc. You have to contact the Village of Belledune. There are certain regulations that must be followed, for example the size of the pipes, etc.

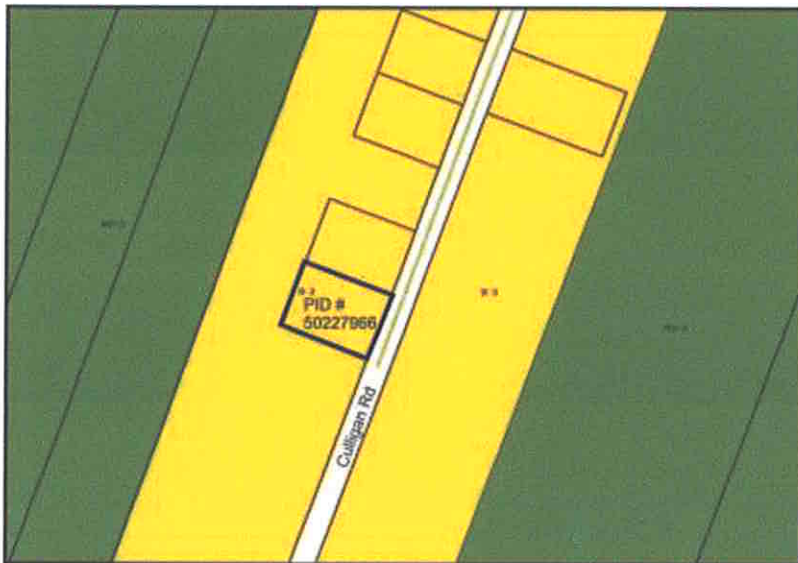
