• Day Care Presentation Report - Next Steps

The meeting was held with local interested people. Information and guidelines can be found via the provincial department responsible for early childhood education. There are two giant hurdles - difficulty catering to all age groups, different rooms are needed and as a business there is not a lot of appetite for. The other possibility is setting up an NPO with available funding from the province and municipality. This will need to be explored and brought back to Council along with names of interested persons. Council could potentially help with the incorporation of the NPO and with space.

• Request Update on Personnel Reviews

Was discussed at working session.

CAO, Lee advised he started in January & February and will have wrapped up by end of April.

• Snow Plowing Committee - Discussion

Basically, Councillor Arseneault could utilize CAO, Lee to review maps, etc. and discuss how to utilize contractors when we can.

• Port of Belledune - Municipal Representative Appointment By-law Relating to the Election of Members of Council Within the Village of Belledune Deputy Mayor, Killoran read a statement regarding the above subject matters, which he had posted on Facebook. In general, he discussed his feeling regarding Port of Belledune municipal representative appointment, the process for having the By-law for Council Composition on the agenda, the denial to video conference in at the previous meeting of Council as well as statements regarding employment hiring practices and lobbying by Council members, etc.

Regional Policing - Discussion

The Chaleur Regional Service Commission's (CRSC) Regional Policing report was referenced and Deputy Mayor, Killoran inquired if any of the cost that the Village incurred for Andrew Amos's study for Belledune would be recouped.

Mayor, Noel advised Belledune's study was separated from the CRSC one.

Further statement included the recommendation in the CRSC report to combine Bathurst and BNPP to make a Regional Police Force (which would include the area of Belledune), the cost sharing based on 50/50 split (population and tax base) and the Minister of Public Safety letter advising that the provincial Department is doing a study of their own regarding policing throughout the province, so will not respond to Belledune's request before this fall.

• Townsite & Industrial Adjacent Property Strategies - Introduction and Discussion

Deputy Mayor, Killoran spoke about the meeting between Maritime Iron and residents of the Townsite and surround area, of which Council was not invited to, which in his opinion was very disrespectful. CAO, Lee was asked to communicate with Maritime Iron so that Council would be kept in the loupe. General discussion was in reference to what happens if Townsite homes and other streets are bought out, Council needs to be in the conversation to facilitate that one.

CAO, Lee advised that in the correspondence with Maritime Iron received today, no decision have been made yet.

Clerk/Treasurer, Cormier as requested by CAO, Lee explained the discussion she had with province regarding the subject matter. The province, during the 2019 Budget review, inquired about the Housing Subsidy Program being proposed and advised that a By-law would have to be developed under the Economic Development Grant and a Policy outlining the process for the Housing Subsidy Program be developed.
