2017 General Operating Fund Budget

Sandenn Killoran moved that the Council of the municipality of Belledune resolves that the sum of \$5,024,507 be the total operating budget of the Municipality, that the sum of \$4,481,052 be the Warrant of the Municipality for the ensuing year, and that the tax rate(s) for the Municipality be \$1.1984 (Central) and \$.9713 (Fringe), seconded by Paul Arseneault. Motion carried. (2 yeas-Councillor's, Killoran & Arseneault) (1 nay - Councillor, Carmichael)

Councillor Killoran inquired as to why Councillor Carmichael voted against the budget.

Councillor, Carmichael noted she does not agree with the 2 cent tax increase and she stated this during the final budget preparation meeting.

Deputy Mayor, Arseneault stated that Councillor, Duivenvoorden had pointed out that Belledune may not be able to provide all the services for the amount they are doing now. If there is no increase, we could be faced with an unbelievable tax rate. Citizens need to get use to the fact that an increase needs to take place. As a responsible government we need to do things that may not be palatable but good for the municipality.

2017 General Utility Fund Budget

2016 Year End Financial – Reserve Fund

Paul Arseneault moved that \$315,000 of the \$600,000, transferred by Motion # M 2016/11/21-235, be transferred back from the 2016 General Operating Fund to the General Capital Reserve Fund, leaving a balance of \$285,000 as the transfer from the General Capital Reserve to the General Operating Fund for the year 2016, seconded by Sandenn Killoran. Motion carried.

Lilliane Carmichael moved that \$2,500 be transferred from the 2016 Utility (Water & Sewer) Operating Fund to the Utility Capital Reserve Fund, seconded by Paul Arseneault. Motion carried.
